**USAMMA** The U.S. Army Medical Materiel Agency, Fort Detrick, Maryland, serves as The Army Surgeon General's executive agent for all strategic medical logistics programs and initiatives including the security assistance mission for the MEDCOM. The Agency serves as the command case manager for Foreign Military Sales and is the sole Army contact for the sale of complex, service unique medical materiel.

Security Assistance is a group of programs authorized by the Foreign Assistance Act of 1961, and the Arms Export Control Act of 1976 as well as other related statutes by which the United States provides defense articles, military training, and other defense related services, by grant, loan, credit or cash sales in furtherance of national policies and objectives. In performing this function, USAMMA's FMS staff interfaces with foreign governments, security assistance organizations and other U.S. Government agencies to define the requirements involved in responding to Security Assistance requests.



USAMMA's Foreign Military Sales Office offers technical and logistical expertise to countries that have special equipment needs. Clinical engineers are available to survey facilities and existing equipment, designing and providing recommendations based on the type and number of facilities, patient capability, and location. Many times, existing systems such as the Deployable Medical Systems and diagnostic imaging equipment are tailored based on customer requirements. By employing a total package approach, we ensure that each customer is afforded the opportunity to plan or obtain the support articles and services required to introduce and operationally sustain equipment considered for purchase.
